Mobile phones and real pandemics

Can the adage, "Everything that is exaggerated is unimportant" be applied to the present avalanche in the media across the Atlantic of dire warnings affecting the 400 million people who use mobile phones? At long last the Americans are waking up to the fact that they have been completely misled about the dangers of exposure to nearby sources of artificial microwave radiation coming from their "precious mobile phones".

Considering the evidence from scientific studies which almost all come to the same alarming conclusions, it is highly probable that a genuine pandemic is brewing that will impact 400 million phone users, a stupendous number.

[Nokia](#) for instance says this in its safety advice:

"... this apparatus conforms to the regulations concerning exposure to radio frequencies [ie. artificial HF microwaves] when used in its normal position against the ear or [such precision!] at a distance of at least 2.2cm from the body".

How has it arisen, this catastrophe that is going to hit young people the hardest?

The story starts several years ago. Since the mobile phone manufacturers did not want to follow the same thorny path as [the tobacco companies](#), they took the initiative by getting a firm grip on the supposedly official world health system.

Something not too unlike "a mafia network" was put in place by a key player, [Michael Repacholi](#), the person in charge of the WHO study programme on electromagnetic fields. Obviously this appointment only continued with the approval of successive directors of the WHO, and in fact the present director, Margaret Chang, has always been a faithful supporter of Repacholi.

Since this arrangement did not look entirely convincing, this same crook Repacholi, the puppet of the manufacturers, set up the pseudo-scientific organisation ICNIRP to rubber-stamp the recommendations from WHO - the very ones that he had himself issued!

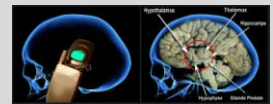
As a barrier against any possible interference, Michael Repacholi was even, in violation of WHO statutes, made the Founder-President of ICNIRP, a scandal for a public servant!

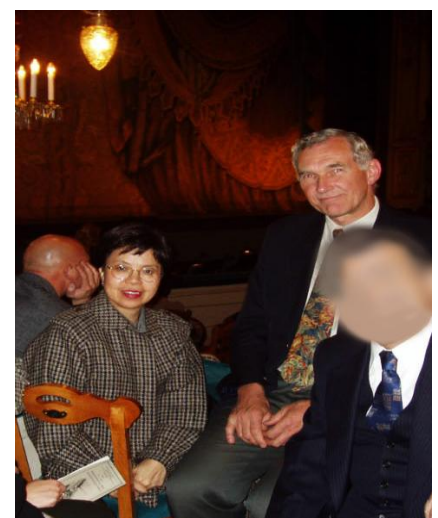

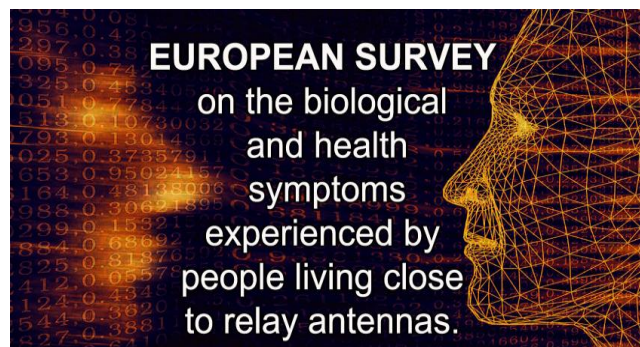
