



The Maciejczyk family case.

The small town of Polanica-Zdrój, located in Poland, is a famous spa town with many hotels and resorts.

Unfortunately in December 2000, a large part of its inhabitants saw their life drastically changed after the installation of 4 antennas for mobile phone (900mHz) on the top of the church tower, and this despite protestations and petition signed by more than 250 residents.

As it is often the case when such installation is made in the middle of a town, the azimuths of the radiations lobes are directed towards inhabited areas. The first azimuth is exactly directed towards a children nursery and ...the hospital, (exactly like in Crest, France) and at less than 50 meters distant from them!

The two other azimuths are directed towards a road and a residential area.

Deleterious consequences were, as usual, immediate for sensitive or weakened people.

A lot of children, among whom Katarzyna, 18 year old or Jan Christian 12,

experience frequent nose bleedings

(this is an usual observationlig, i.e. in Crest and at Labruyère school in Valence, France).

All this symptoms have been certified by physicians (non exhaustive list):

Dermatosis and dermatites, swollen parts of the bodies, modification of hemogram, increase of body's temperature, with amelioration during the night or disappearance of symptoms out from home, pain in spinal column or in joints, arterial hypertension, dizziness and headaches, asthenia, loss in concentration and intellectual faculties, etc...

These problem are even stronger for children, who also show nervousness,

loss of appetite and various somatic problems.

More severe conditions, like lung or above all kidney diseases, have been certified by doctors.

Paradoxically, the origin of these health effects has been identified by the hospital.

We also must add that a large number of people live under a permanent stress.

We took a concrete example to illustrate this file about dermatosis and dermatitis:

The Maciejczyk family: Monika, Winchester and their daughter

who live near the church tower, where the antennas are located.

We should have chosen other towns which have a similar destiny, for example

Brodnica (Pommern) and Swidnica (Niederschlessien), Rybnik, Slupsk, Warszawa . . .

Their health has been at its worst in 2002. Since this date, the hospital saw light and occasional improvements concerning some of the symptoms.

The residents have taken their own destiny in hands, they gathered information.

And, as usual, the authorities proposed them official measurements...

and, as usual the measures never exceeded authorized levels.

And as always...officially, there is not any problem!

So the influence of Electro Magnetic radiations was put aside, despite medical diagnosis!

They decided to go into Court and won in 2004 a judgement that established the antennas were illegal, but... this judgement has not been executed to date!

But, facing a terrible situation, the "Sous préfet" asked for a temporary stop of the radiations, in order to be able to compare the people's health state.

Up to now, the phone company always rejected his request.

The residents, who trust justice, the Law, and the Constitution which should guarantee their physical integrity, do not have any more hope in the future, they hardly understand what is happening to them.

They are asking for help the doctors, the independent scientist community and other people experiencing similar situations.

They appeal to human rights organizations, wanting to help associations which fight for a better future.

The same question always remains: they were having a normal life, why has it been destroyed?
